The motion was seconded by Mr. L. Scott.


The question was on the adoption of the resolution and the roll being called there were FOUR yeas and no nays, and so the resolution was adopted this 12th day of January, 1983.



Viewers in the above entitled proceedings,







ORDER APPOINTING ENGINEER


