ORDER ESTABLISHING IMPROVEMENT AND CONFIRMING THE VIEWERS REPORT

The above entitled matter came on for final hearing by the Board of Managers of the Rice Creek Watershed District on the 16th day of March, 1983, at the City of Shoreview City Hall, Shoreview, Minnesota ___ upon the petition for the improvement of the ditch above described and the reports of the engineer and viewers appointed herein. The petitioners appeared by Barbara Farrell, attorney at law, Minneapolis, No one Minnesota, and appeared in opposition thereto. The engineer appointed by the said managers to survey said ditch and Malcolm Allen, Malcolm Watson and Albert Kordiak being all present and being all of the viewers appointed herein; and the said managers having heard said petition, all persons and parties interested, both for and against the establishment and construction of said improvement, and all evidence produced by them, and having considered the same, together with the report of the viewers and the report of the engineer, and the reports of the Minnesota Water Resources Board and the

Director of the Division of Waters of the Department of

Natural Resources of the State of Minnesota, find the following

First. That notice of said hearing was posted and served on the appropriate officers of the Department of Natural Resources and the Water Resources Board, and on all persons, corporations, and public bodies affected by said improvement as by law required, that said notice was published, and that proofs of service, posting and publication have been filed in the office of said managers.

Second. That the reports of said engineer and viewers have been duly made and filed in the office of said managers, and that said reports as made and amended are complete, just and correct, and that all other proceedings in this matter have been had and taken, in accordance with the provisions of law relating thereto.

Third. That the estimated benefits to be derived from the improvement of said ditch are greater than the total estimated costs, including damages, and that said damages and benefits have been duly determined as required by law, and that said improvement will be of public utility and benefit, and will promote the public health and welfare, and is practicable.

Fourth. That the location of the improvement of said ditch is shown in the ______ Final Report of the Engineer in this matter, on file in the office of the Board of Managers as part of the record of this proceeding.

Fifth. That said ditch improvement lies wholly within Ramsey County, Minnesota.

Sixth. That said improvement of Ramsey County Ditch No. 8 changes the course of a part of said ditch as originally established.

Seventh. That the centerline of Ramsey County
Ditch No. 8 as improved by said improvement runs through
the bodies of water identified as Kerry Lake in the official

plat of Evergreen Shores, Ramsey County, Minnesota and over the Westerly 20 feet of Lot 7, Block 5, Evergreen Shores.

Eighth. That said improvement is in compliance with the provisions and purposes of applicable Minnesota Statutes.

NOW THEREFORE, IT IS ORDERED AND ADJUDGED:

First. That the improvement of said drainage
ditch, be and hereby is ordered and established, as specified
in the Final Report of the
Engineer in this matter, on file in the office of the said
managers as a part of the record of this proceeding.
Second. That the Final Report of the
Engineer appointed by this Board of Managers, and on file
in this matter, be and the same is in all things adopted and
confirmed.

Third. That the Final Report of the viewers appointed by this Board of Managers, and on file in this matter, be and the same hereby is in all things adopted and confirmed, and that the damages therein specifically arising from the construction of said improvement be and they are in all things allowed and confirmed, and that the same be paid in the manner provided by law.

Fourth. That the location of part of Ramsey County Ditch No. 8 is hereby changed from its location as originally established to the location of said improvement, as shown on Sheet No. 1 of the Plans entitled Ramsey County Ditch No. 8 Improvements, Rice Creek Watershed District Project No. 77-22, as prepared by Richard M. Greenlee and dated March 10, 1983, which Plans are a part of the ________ Report of the Engineer in this matter.

Fifth. That the costs of said improvement and all other expenses thereof, and of the proceedings therefor are

in all things allowed and confirmed, and shall be paid according to law.

Sixth. That a statement listing the property and corporations benefited or damaged or otherwise affected by the within improvement as found herein shall be filed with the County Auditor of Ramsey County, Minnesota.
