Notice of hearing Petition and Engineer's and Viewers' Report.

TO WHOM IT MAY CONCERN:-

Notice is hereby given that a petition for the construction of a judicial ditch in the Town of Blaine, County of Anoka, Minnesota, and the Town of Mounds View, County of Ramsey, Minnesota, together with such branches and laterals as may be necessary to effectually drain the lands described in said petition, has been filed in the office of the clerk of the above named Court; That the preliminary hearing upon said petition has been duly had by said Court; and that the report of the engineer appointed by the Court to survey said ditch, and the report of the viewers appointed by the Court to view the same, have been duly made and filed in the office of the clerk of the above named Court, and are now pending in said Court;

That the starting points and termini of the said ditch and branches, as appears by the engineer's report, together with a description of the lands through which they pass, as shown by such report, are substantially as follows, to-wit:-

Main Ditch:- Commencing at a point north 88 deg. and 35 mins. west 665 feet from the 1/16 corner on the west side of the SW 1/4 of Sec. 26, Twp. 31, Rnge. 23, Anoka Co., Minn., on the NE 1/4 of the SE 1/4 of sec. 27, said town and range, thence southerly through said NE 1/4 of SE 1/4 and southerly and southwesterly through the SE 1/4 of SE 1/4 of said section, and continuing southwesterly through the NE 1/4 of NE 1/4 of Sec. 34, and southwesterly and southerly through the NW 1/4 of NE 1/4 of said section, and southerly through SW 1/4 of NE 1/4 of said section, and southerly and southwesterly through the NW 1/4 of SE 1/4 of said section, and southwesterly through the NE 1/4 of SW 1/4 of said section, and southwesterly through the SE 1/4 of SW 1/4 of said Section, and thence southwesterly and southerly through the SW 1/4 of SW 1/4 of said section, all of the above being in Twp. 31, Rnge. 23, to the County line between Anoka and Ramsey Counties; thence southerly and southeasterly through the NE 1/4 of NW 1/4 and SE 1/4 of NW 1/4 and SW 1/4 of NE 1/4 to the south line thereof, thence east along south line of SW 1/4 of NE 1/4 to station 127 plus 91, thence southerly through the NW 1/4 of SE 1/4 and thence easterly through the NE 1/4 of SE 1/4, to the east line thereof, at station 156, all in section 5, Twp. 30, Rnge. 23, thence southeasterly through the SW 1/4 of SW 1/4 of section 4, said town and range, to Rice Creek; at Sta. 163 plus 80, and there to terminate;

Branch One:- Commencing in the southerly end of the SW 1/4 of SE 1/4, thence running south 25 deg. 7 mins. East to station 1, on the south line of said SW 1/4 of SE 1/4, and at a point 576 feet west from the southeast corner of said land, ~~thence southerly through the NW 1/4 of NE 1/4 and the NE 1/4 of NE 1/4 of Section 34, to the main ditch at sta. 23, all in Twp. 31, Rnge. 23, Anoka County;~~ ~~thence southerly through the NW 1/4 of NE 1/4 and the NE 1/4 of NE 1/4 of Section 34, to the main ditch at sta. 23, all in Twp. 31, Rnge. 23, Anoka County;~~ all in section 27, thence southeasterly through the NW 1/4 of NE 1/4 and the NE 1/4 of NE 1/4 of Section 34, to the main ditch at sta. 23, all in Twp. 31, Rnge. 23, Anoka County;

Branch Two:- Commencing at a point N 88 deg. 35 mins. E 775 feet from the 1/16 corner on west side of SW 1/4 of Sec. 26, thence southerly through SW 1/4 of SW 1/4 of Sec. 26, and NW 1/4 of NW 1/4 and SW 1/4 of NW 1/4 and NW 1/4 of SW 1/4 of sec. 35, and thence southwesterly through NE 1/4 of SE 1/4 and SE 1/4 of SE 1/4, thence westerly through SW 1/4 of SE 1/4 and NW 1/4 of SE 1/4, and to main ditch at sta. 58, on the NE 1/4 of SW 1/4, all in sec. 34, Twp. 31, Rnge. 23, Anoka Co. Minn.

Lateral One of Branch Two:- Commencing at 1/16 line between the NE 1/4 and NW 1/4 of SW 1/4 of Sec. 35, at a point 360 feet north from the center of the SW 1/4 of said section, thence southerly 360 feet, to said center, and southerly and westerly through the SE 1/4 of SW 1/4 and S 1/4 of SW 1/4 of section 34, and northwesterly through SE 1/4 of SE 1/4 of Sec. 34, to sta. 66 plus 16 of Branch Two, all in Twp. 31 of Rnge. 23;

Branch Three:- Commencing at a point in the NW 1/4 of NE 1/4 of Sec. 5, Twp. 30, Rnge. 23, Ramsey Co., Minn., thence northwesterly 300 feet to the County line at a point 610 feet east from the 1/4 corner on the north side of said section 5; thence northwesterly through the SE 1/4 of SW 1/4 and SW 1/4 of SW 1/4 of section 34, Twp. 31, Rnge. 23, to sta. 73 plus 32 of main ditch;

Branch Four:- Commencing at a point in the NE 1/4 of SE 1/4 of Sec. 33, Twp. 31, Rnge. 23, 323 feet east from the center of said SE 1/4, thence westerly and southerly through the SE 1/4 of SE 1/4 of said section to a point 33 feet north of the County line; thence east parallel with the County line, through the SE 1/4 of SE 1/4 of Sec. 33, and SW 1/4 of SW 1/4 of sec. 34, said Twp. and rnge., to sta. 83 of main ditch;

Branch Five:- Commencing at a point in the SE 1/4 of SW 1/4 of Sec. 5, Twp. 30, Rnge. 23, Ramsey County, thence southeasterly 500 feet to the north line of said tract, 660 feet west from the northeast corner thereof, thence northerly and northeasterly through the NE 1/4 of SW 1/4 and the NW 1/4 of NE 1/4 of said section, to station 120 plus 11 of main ditch;

Branch Six:- A small ditch 800 feet in length commencing in the northwest corner of SE 1/4 of NW 1/4 of sec. 5, Twp. 30, Rnge. 23, thence northeasterly through said tract and the NE 1/4 of NW 1/4 of said section, to station 100 of main ditch;
