 Addition, and Lots 7 and 8, Block 72
 and west half of Block 80, Banning &
 Olivier's Addition. Also all of Kribbs
 and Gillis' Subdivision of Block 88,
 Banning & Olivier's Addition, also all
 of Lawton's Re-arrangement of east 1/2
 of Block 80, Banning & Olivier's Addi-
 tion, and all of Dawson's Rearrange-
 ment of Block 81, Banning & Olivier's
 Addition. Also Lots 1 and 2, Block 4,
 Langerin's 5th Addition. Also all of
 Blocks 2 and 3, of Grand View Addi-
 tion.
 (2) That the following land, lands
 therein be and the same are hereby
 taken, appropriated and condemned
