This is to certify that this plat of lands and grounds has been designated and has been caused to be surveyed and platted by the Board of Park Commissioners of the City of St. Paul for the purposes of a public parkway for the use of said city to be called MOUNDS BOULEVARD, by and under resolutions of said board adopted on the 31st day of March 1914, and comprising the following tracts of land situated in the City of St. Paul, to wit:

- Lots 3 and 4, and the southerly 50 feet of lots 1 and 2, in William's Add. No. 2
- The southerly 50 feet of lots 1-2-3-4 and 5, in George B. Nienaber's Sub.
- Lots 11 to 18 inclusive in Block 18, in Lyman Dayton's Add.
- All that part of tract lying West of Block 28 that lies Southwesterly of a line drawn from the south corner of Lot 10 Block 18 to the north corner of Lot 15 Block 32.
- All that part of Lots 1-14 and 15 Dayton Place Addition that lies Southwesterly of a line drawn from the south corner of Lot 9 Block 32 to the north corner of Lot 12 Stinson's Re-Ar. of Block 45
- Lots 12 to 17 inclusive in Stinson's Re-Ar. of Block 45, in Wagener's Sub.
- Lot 1, in Munch's Sub.
- Lots 1 to 11 inclusive, in Suburban Hills Addition
- Lot 1 and the southerly 50 feet of lot 2 in Block 5,
- All of Lots 16 to 28 inclusive in Block 17 not already taken,
- Lots 7 and 8 and that part of lot 5, block 24 not already taken
