Northeast Corner of Section 15, Township 29 North, Range 23 West

Set post Corner to Sections 10, 11, 14 and 15, Bur Oak 12 S40°W 140, B. Oak 15 N17°W 1.69, November 3, 1847.

The Northeast Corner of Section 15 was fixed from Government Witness trees and also found iron stake at Section Corner, tied it and set monument, June 17, 1896.

AUDITOR'S SUBDIVISION No. 46 Ramsey County. Minn, shows a granite monument at this location, January 2, 1907.

Ties placed on granite monument, March, 1959 (See Ramsey County Survey, Green Book, "ROSE").

Found a P.K. nail, checked location (see Survey Book No. 1, pages 21 and 23), see Sheets 3 and 4 of 4-Sheets.

Set a cast iron monument. No date given in survey field book.

Tied monument, July 28, 1975.

Checked monument, July 29, 1977.

Monument destroyed during road construction; reset monument, April, 1981.

Tied out monument and set a 20 in. cast iron monument, 1.5 ft. below grade, April 15 and 29, 1998.

Set a cast iron manhole assembly over monument, July 24, 1998.

Retied monument, July 11, 2006.

Retied cast iron monument within a cast iron mahole assembly, June 20, 2011.
