PROPOSED LEGAL DESCRIPTION AFTER EXCHANGE:

Line A is described as follows: Commencing at an iron monument at the Southwest corner of Lot 16 in Block 37, St. Anthony Park North, Ramsey County, Minnesota, thence on an assumed bearing of North 73 degrees 01 minutes 39 seconds East along the Southerly line of said Block 37, a distance of 33.52 feet to the most easterly corner of said Lot 16, thence North 16 degrees 54 minutes 10 seconds West a distance of 168.69 feet to the point of beginning of Line A; thence South 67 degrees 03 minutes 06 seconds West a distance of 59.16 feet to an iron monument; thence South 67 degrees 03 minutes 06 seconds West a distance of 133.39 feet to an iron monument: thence South 67 degrees 03 minutes 06 seconds West a distance of 8 feet, more or less, to an intersection with the westerly line of said Block 37 and there terminating.

Line B is described as follows: Commencing at an iron monument at the Southwest corner of Lot 16 in Block 37, St. Anthony Park North, Ramsey County, Minnesota, thence on an assumed bearing of North 73 degrees 01 minutes 39 seconds East along the Southerly line of said Block 37, a distance of 33.52 feet to the most easterly corner of said Lot 16, thence North 16 degrees 54 minutes 10 seconds West a distance of 75.21 feet to the point of beginning of Line B: thence South 72 degrees 40 minutes 54 seconds West a distance of 52.02 feet to an iron monument; thence continuing South 72 degrees 40 minutes 54 seconds West a distance of 138.12 feet to a drill hole and "X" in a concrete retaining wall; thence South 72 degrees 40 minutes 54 seconds West a distance of 10 feet, more or less, to an intersection with the westerly line of said Block 37 and there

That part of Lots 18 and 19 in said Block 37 lying southerly of said Line A and northerly of said


- 1. Showing the beginning point, direction and length of Line A and Line B and the location of Line A and Line B in relation to certain existing permanent structural improvements (dwellings, garages, fence, retaining walls and curbs) on Lots 17, 18, 19, and 20 all in Block 37, St. Anthony Park North, Ramsey County, Minnesota.
- 2. The platted boundaries of Lots 17, 18, 19, and 20 have not been surveyed. The plat of St. Anthony Park North is old (1884) and contains scant and vague measurements to define the lots therein and the iron monuments we have found and shown on this survey are not in complete
- 3. The iron pipes and the drill hole and "X" called for on Lines A and B do not purport to be at the ends of those lines nor do they purport to mark the boundaries of Block 37 or the adjacent alley. The location of the sidewalks on Como and the paved alley are closer together than the plat dimensions would indicate but for practical purposes they may be the easterly and westerly lines of the properties unless a court decides otherwise.
