PROPOSED DESCRIPTION OF PARCEL B

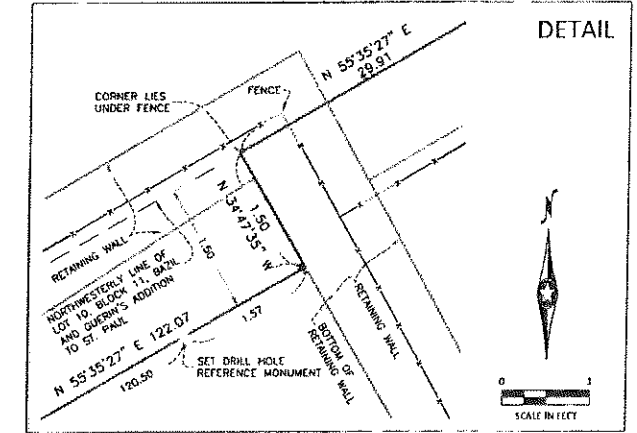

AND

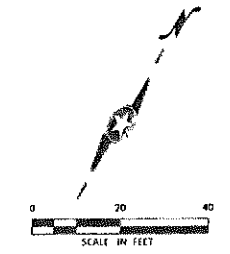
