

FINAL ORDER IN CONDEMNATION PROCEEDINGS.

C. F. No. 13342—

In the matter of opening, widening and extending Como avenue west to a width of 73 feet from North City Limits to West City Limits, the land to be taken being more particularly described as a strip of land seven feet in width, along the southerly side of Como avenue West, from the Westerly City Limits, easterly to the easterly line of a tract of land owned by the Peteler Car Company bankrupt. Said easterly line intersecting the southerly line of Como avenue west at a point 574 feet westerly of the center line of Eustis street, under Preliminary Order 6112, approved July 22nd, 1915, Intermediary Order 10,287, approved May 2nd, 1916.

Resolved:

(1) That the following improvement be and the same is hereby ordered to be made, viz: Open, widen and extend Como avenue west to a width of 73 feet from north City Limits to West City Limits.

(2) That the following land, lands, or easements therein be and the same are hereby taken, appropriated and condemned for the purpose of making the said improvement, viz: A strip of land seven feet in width along the southerly side of Como avenue West, from the westerly City Limits, easterly to the easterly line of a tract of land owned by the Peteler Car Company bankrupt. Said easterly line intersecting the southerly line of Como avenue West at a point 574 feet westerly of the center line of Eustis street.
