



MINARY ORDER.

No. 34199—

Abstract.

Whereas, A written proposal for the doing of the following improvement.

To enlarge the intersection of Como Ave. West, Langford Ave. and Knapp Place, by condemning and appropriating such portions of Lots 13, 14, 15, 16 and 17, Block 44, St. Anthony Park North, as will facilitate traffic conditions in said vicinity, having been presented to the Council of the City of St. Paul therefore, be it

Resolved, That the Commissioner of Public Works be and he is hereby ordered and directed:

1. To investigate the necessity for or desirability of the making of said improvement.

2. To investigate the nature, extent and estimated cost of said improvement and the total costs thereof.

3. To furnish a plan, profile or sketch of said improvement.

4. To state whether or not said improvement is asked for on the petition of three or more owners.

5. To report upon all of the foregoing matters to the Commissioner of Finance.

F. No. 35017—By H. C. Wenzel—

F. 34525, approved May 27, 1921.

(2) That the following improvements be and the same is hereby taken, appropriated and sketched for the purpose of m fixed and determined the amount of improvement to be taken for the above named project to be as follows: All that part of lots 13, 14, 15, 16 & 17, Block 44, St. Anthony Park North, lying southerly and westerly of a line described as follows: Commencing at the intersection of the North Easterly line of Como Ave. West and the North Easterly line of Knapp St., the line of Como Ave. West and the North Easterly line of Commonwealth Ave. West 21 7/10 ft. less to beginning of curve, continuing along the North Easterly line of Commonwealth Ave. West on a curve to the left radius 606 68/100 feet, through a central angle of 16 degrees 5 minutes, a distance of 170 3/10 feet to the point of beginning thence on a curve to the right, tangent to last described curve, having radius of 300 feet, 20 minutes, a distance of 19 degrees 50 minutes, a distance of 200 71/100 feet, through a central angle of 19 degrees and 50 minutes, a distance of 62 31/100 feet, to a point on the Southerly line of that portion of Commonwealth Ave. lying between Chelmsford Ave. and the Westerly alley in Blk. 44 St. Anthony Park North produced westerly, said point being 4 9/10 feet distant from and easterly of the easterly line of Como Ave. West, produced, measuring along the said southerly line of Commonwealth Ave. produced, with no alternatives, and that the estimated cost thereof is \$1,000.00.

Resolved further, That a public hearing be had on said improvement on the 27th day of June, 1921, at the hour of 10 o'clock A. M., in the Council Chamber of the Court House and City Hall Building in the City of St. Paul. RESOLUTION OF COUNCIL APPROVING ASSESSMENT AND FIXING TIME OF HEARING IN CONDEMNATION PROCEEDINGS.

In the matter of enlarging the intersection of Como Ave. West, Langford Ave. and Knapp Place, by condemning and appropriating such portions of Lots 13, 14, 15, 16 and 17, Block 44, St. Anthony Park North, as will facilitate traffic conditions in said vicinity, under Preliminary Order 34199, approved May 10, 1921, Intermediary Order 34525, approved May 27, 1921.

The Commissioner of Finance having submitted his report in the above matter as to the amount of damages awarded for the taking of the land or easements therein appropriated for the above improvement and to whom payable; and also having submitted his assessment of benefit to property from the making of said improvement, therefore be it

Resolved, That the said assessment of benefits be and the same is hereby approved.

A public hearing having been had upon the taking and condemnation of the lands or easements therein, for the above improvement, and the awards of damages therefor, and also upon the assessment of benefits therefor, and the Council having duly considered the same, now therefore be it

That the nature of the improvement which the Council recommends is enlarge the intersection of Como Ave. West, Langford Ave. and Knapp Place, by condemning and appropriating such portions of Lots 13, 14, 15, 16 and 17, Block 44, St. Anthony Park North, as will facilitate traffic conditions in said vicinity, being more particularly described as follows: All that part of lots 13, 14, 15, 16 and 17, Block 44 St. Anthony Park North lying southerly and westerly of a line described as follows: Commencing at the North Easterly line of Como Ave. West and the North Easterly line of Knapp St., the line of Como Ave. West and the North Easterly line of Commonwealth Ave. West 21 7/10 ft. more or less to beginning of curve, thene continuing along the North Easterly line of Commonwealth Ave. West on a curve to the right, tangent to last described curve, having radius of 300 feet, through a central angle of 38 degrees 20 minutes, a distance of 200 71/100 feet, thene on a curve to the right, tangent to last described curve, having radius of 180 feet, through a central angle of 19 degrees and 50 minutes, a distance of 62 31/100 feet, to a point on the Southerly line of that portion of Commonwealth Ave. lying between Chelmsford Ave. and the Westerly alley in Blk. 44 St. Anthony Park North produced westerly, said point being 4 9/10 feet distant from and easterly of the easterly line of Como Ave. West, produced, measuring along the said southerly line of Commonwealth Ave. produced, with no alternatives, and that the estimated cost thereof is \$1,000.00.
