All that part of Lots 5 and 6, Block 2, Oak Point and adjoining vacated Owasso Blvd. S. lying NEly of the following described line: Beginning at a point on the West line of said Lot 5 distant 100 feet south of the NW corner of said Lot 5, thence SEly to a point on the NWly Right-of-Way line of N.P. Ry distant 100 feet SWly from a point of intersection of the NWly Right-of-Way line of N.P. Ry and the NEly line of said Lot 6 extended Southerly.

Description:

All that part of Lots 5 and 6, Block 2, Oak Point, adjoining vacated Owasso Blvd. S. and W. Heinel Drive lying SWly of the following described line; beginning at a point on the West line of said Lot 5 distant 100 feet South of the NW corner of said Lot 5, thence SEly to a point on the NWly Right-of-Way line of N.P. Ry. distant 100 feet SWly from a point of intersection of the NWly Right-of-Way line of N.P. Ry, and the NEly line of said Lot 6 extended Southerly; and

Heinel Drive; lying NEly of the following described line: beginning at a point on the NWly line of said Lot 1 distant 115.63 feet NEly from the West Corner of said Lot 1, thence SEly at right angles to said NWly line of lot 1 a distance of 160 feet to a point on the NWly Right-of-Way line of N.P. Ry. and there terminating.
