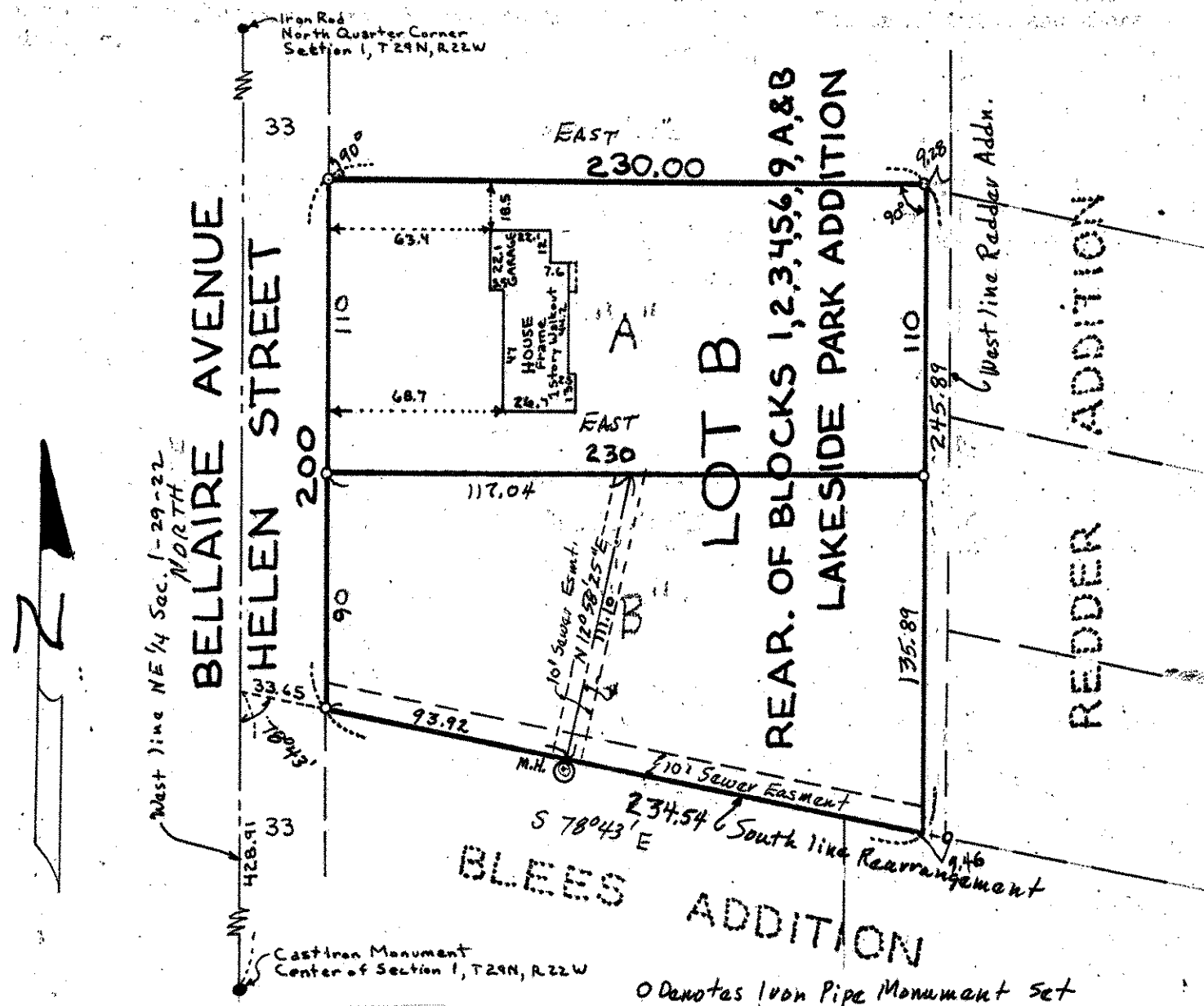

DESCRIPTION: (Total-as furnished)

That part of Lot B, Rearrangement of Blocks 1,2,3,4,5,6,9, A and B, Lake Side Park Addition to North St. Paul described as beginning at the Southwest corner of said Lot B; thence Northerly 200 feet along the West line of said Lot B; thence at right angles 230 feet to a point; thence at right angles to the South line of said Lot B; thence to the point of beginning. Subject to 10 foot sewer easement along Southerly 10.0 feet thereof.

DESCRIPTION: (Parcel A)

The North 110 feet of that part of Lot B of Rearrangement of Blocks 1,2,3,4,5,6,9, and A and B, Lake Side Park Addition to North St. Paul described as beginning at the Southwest corner of said Lot B; thence Northerly 200 feet along the West line of said Lot B; thence at right angles 230 feet to a point; thence at right angles to the South line of said Lot B; thence to the point of beginning, together with a 10 foot sewer easement, the center line of which is described as commencing at the southwest corner of said Lot B; thence S 78° 43' E (assumed bearing) along the southerly line of said Lot B a distance of 93.92 feet to the point of beginning of the center line of said 10.0 foot easement; thence N 12° 58' 25" E to the South line said parcel, the side lines of said easement are extended or shortened to close upon the South line of said parcel described herein.

Except the North 110.0 feet thereof, that part of Lot B of Rearrangement of Blocks 1,2,3,4,5,6,9, A and B, Lake Side Park Addition to North St. Paul described as beginning at the Southwest corner of said Lot B; thence Northerly 200 feet along the West line of said Lot B; thence at right angles 230 feet to a point; thence at right angles to the South line of said Lot B; thence to the point of beginning, subject to a 10 foot sewer easement along the Southerly 10.0 feet thereof and subject to a 10 foot sewer easement, the center line of which is described as commencing at the southwest corner of said Lot B; thence S 78° 43' E (assumed bearing) along the southerly line of said Lot B a distance of 93.92 feet to the point of beginning of the center line of said 10.0 foot easement; thence N 12° 58' 25" E to the North line of said parcel, the side lines of said easement are extended or shortened to close upon the North line of said parcel described herein.
