
## CERTIFICATE OF SURVEY



## **DESCRIPTION**

Street

All that part of the Southwest Quarter of the Northwest Quarter of Section 7, Township 29 North, Range 22 West, Lots 15, 16, 17 and 18, Block 3 and Lots 15 and 16, Block 4, together with that part of the vacated alleys and vacated Hawley Street, TERRACE HEIGHTS, and any part of Block 1, NORTH RICE STREET ACRE LOTS, according to the recorded plats thereof, Ramsey County, Minnesota, described as follows:

Beginning at the West Quarter Corner of said Section 7; thence North 00 degrees 45 minutes 32 seconds West, along the west line of said Southwest Quarter of the Northwest Quarter, a distance of 155.12 feet; thence South 89 degrees 57 minutes 15 seconds East a distance of 53.01 feet; thence South 02 degrees 41 minutes 36 seconds East a distance of 74.40 feet; thence South 50 degrees 50 minutes 44 seconds East a distance of 34.70 feet; thence South 89 degrees 05 minutes 53 seconds East a distance of 92.10 feet; thence South 88 degrees 03 minutes 21 seconds East a distance of 136.70 feet; thence South 82 degrees 35 minutes 23 seconds East a distance of 108.50 feet; thence South 87 degrees 23 minutes 50 seconds East a distance of 136.39 feet, to a point 33.00 feet perpendicular and northerly of the south line of said Southwest Quarter of the Northwest Quarter; thence South 00 degrees 02 minutes 45 seconds West a distance of 33.00 feet to said south line of said Southwest Quarter of the Northwest Quarter; thence North 89 degrees 57 minutes 15 seconds West, along said south line a distance of 553.88 feet to the point of beginning.
