

# AN ORDINANCE AMENDING ORDINANCE 98-478 BY CORRECTING THE LEGAL DESCRIPTION OF LAND BEING EXCHANGED

WHEREAS, On November 24, 1998 the Ramsey County Board of Commissioner approved a land exchange, by Ordinance No. 98-478, to the mutual benefit of Ramsey County and the City of Shoreview; and

WHEREAS, The approvals required by Ordinance 98-478 were obtained from the Metropolitan Council and the U.S. Department of the Interior; and

WHEREAS, Ordinance 98-478 found the exchange in the public interest and consistent with the no net loss of park land provision of the Ramsey County Home Rule Charter; and

WHEREAS, The Ordinance contained legal descriptions of the lands to be exchanged which contained errors and which were appropriately rejected by the Ramsey County Recorder's Office; and

WHEREAS, The Ramsey County Surveyor's Office has corrected the errors in the legal description; and

WHEREAS, Said corrections result in no substantive change to the intent of the proposed exchange; and

WHEREAS, Ramsey County and the City of Shoreview mutually wish to effectuate the original intent of the parties at this time; Now, Therefore
