**Description:**

All that part of Lots 6 and 7, Block 23 and the adjoining vacated alley in Block 23; All that part of Lots 1 thru 12, Block 24 and the adjoining vacated alley in Block 24; and All that part of Lots 1 thru 5 and Lots 10, 11 and 12, Block 25; Dunwell and Spencer's Addition to Brooklynd; and also all that part of vacated Texas St., Chester St. and Wyandotte St. lying within the following described lines:

commencing at the intersection of the centerline of Alabama St. and State St., thence Southerly 186.0 feet along the centerline of State St., thence Southerly 16.60 feet by a deflection angle of  $1^{\circ}51'05''$  to the right to the centerline of Fillmore Ave. (formerly known as Nagasaki Road and Airport Road); thence Easterly 766.06 feet by a deflection angle of  $84^{\circ}13'55''$  to the left along Fillmore Ave.; thence Easterly 76.14 feet by a deflection angle of  $5^{\circ}37'46''$  to the right to a point on the East frontage road of Lafayette Road; thence Southerly 182.54 feet by a deflection angle of  $95^{\circ}03'32''$  to the right; thence Southeasterly 151.25 feet by a deflection angle of  $18^{\circ}00'$  to the left; thence Northeasterly 22 feet at right angles; thence Northeasterly 315.5 feet by a deflection angle of  $0^{\circ}43'28''$  to the left, thence Southeasterly 320.07 feet at right angles to the point of beginning of the parcel of land herein described; thence continuing Southeasterly 231.47 feet along the aforesaid line extended; thence Northeasterly 620.25 feet at right angles, thence Northwesterly 205.74 feet by a deflection angle of  $115^{\circ}39'10''$  to the left along the Southwesterly line of Fillmore Ave. to a point of curve; thence Northwesterly along a curve with a radius of 1145 feet and a deflection angle of  $2^{\circ}34'57''$  to the left for an arc distance of 51.61 feet along the Southwesterly line of Fillmore Ave.; thence Southwesterly 507.79 feet by a deflection angle of  $61^{\circ}45'13''$  to the left from tangent of curve to the point of beginning.
