

Description:

Lots 5 and 6, and that part of Lots 3, 4, 7 and 8, Block 13; and Lots 1, 2, 3, 8, 9, 10, 11 and 12, and that part of Lots 4, 5, 6 and 7, Block 14; and that part of Lots 8 and 7, Block 8, lying Northerly of Nagasaki Road; and that part of Lots 10, 11 and 12, Block 7, lying Northerly of Nagasaki Road; and all that part of the vacated alleys in Blocks 13 and 14; all in Town of Brooklynd; and all that part of vacated Chester St., Wyandotte St. and Tennessee St. lying within the following described lines: Commencing at the intersection of the Southerly line of Alabama St. and the Easterly right-of-way line of Lafayette Road, said point being 693.91 feet Easterly of the Northwest corner of Block 11, Town of Brooklynd; thence Northeasterly along said Southerly line of Alabama St. 302 feet to the point of beginning of the land to be described; thence Southerly by a deflection angle of $122^{\circ}07'$ to the right, a distance of 366.12 feet to the Northerly line of Nagasaki Road as widened; thence Easterly along the Northerly line of Nagasaki Road by a deflection angle of $103^{\circ}47'20''$ to the left, to the tangent of a curve $\Delta = 10^{\circ}03'$ to the right, $R = 1603.59'$; a distance of 281.27 feet to the point of compound curve; thence Easterly on a curve, $\Delta = 3^{\circ}38'50''$ to the right, $R = 1255'$; a distance of 79.89 feet; thence Northerly at right angles to the tangent on a radial line of said curve a distance of 544.48 feet to the Southerly line of Alabama St.; thence Southwesterly along the Southerly line of Alabama St. by a deflection angle of $122^{\circ}01'30''$ to the left, a distance of 421.02 feet to the point of beginning. Subject to a utility easement on and across the Westerly 10 feet of said parcel.
