All of Lots 7, 8 and 9 and parts of Lots 4, 5, 6, 10 and 11, Block 7, and adjoining vacated alley; and All of Lot 6 and parts of Lots 4, 5 and 7, Block 14, and adjoining vacated alley; Town of Brooklynd. All of Lots 1, 8, 9, 10, 11 and 12 and parts of Lots 2, 3, 4, 5 and 7, Block 6, and adjoining vacated alley; All of Lots 1, 2, 3, 4, 5 and 6 and parts of Lots 7, 8, 9, 10, 11, and 12, Block 15, and adjoining vacated alley; Parts of Lots 1, 2, 3, 4 and 12, Block 29, and adjoining vacated alley;

Parts of Lots 11 and 12, Block 28; Dunwell and Spencer's Addition to Brooklynd.

All that part of vacated Tennessee St., Kentucky St., Wyandotte St. and Rutland St.

all lying within the following described lines:

Commencing at the intersection of the Southerly line of Alabama St. and the Easterly right-of-way line of Lafayette Road, said point being 693.91 feet Easterly of the Northwest corner of Block 11, Town of Brooklynd, thence Northeasterly along the Southerly line of Alabama St. a distance of 672.49 feet to a point of curve, thence Easterly along a curve for extending Alabama St. parallel to and distant 78 feet from the centerline of the C.R.I. and P. Railway for an arc distance of 99.86 feet,  $\Delta = 8^{\circ} 20' 30''$  to the right, and  $R = 685.94$  feet, to the point of beginning of the parcel of land herein described, thence continuing Easterly along aforesaid curve extended an arc distance of 570.77 feet,  $\Delta = 47' 40'' 32''$  to the right and  $R = 685.94$  feet, thence Southerly by a deflection angle of  $84^{\circ} 16' 10''$  to the right from the tangent of aforesaid curve for a distance of 659.23 feet to a point on the Northerly line of Fillmore Ave. (formerly Nagasaki and Airport road), <sup>693.91 ft. to</sup> <sub>in corner 11</sub> distance of 659.23 feet to a point on
