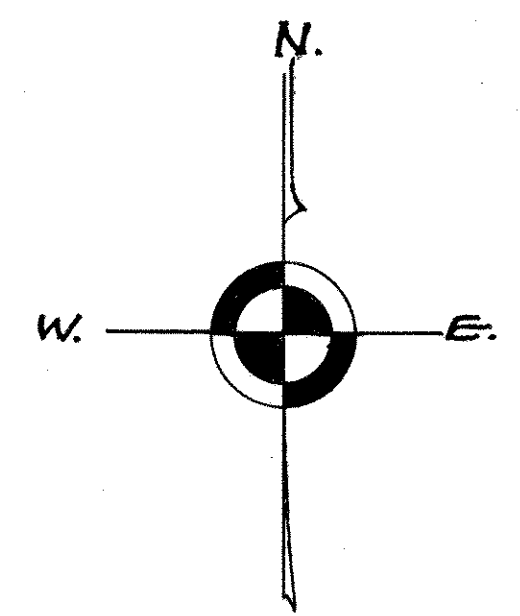


NOHA'S ADDITION

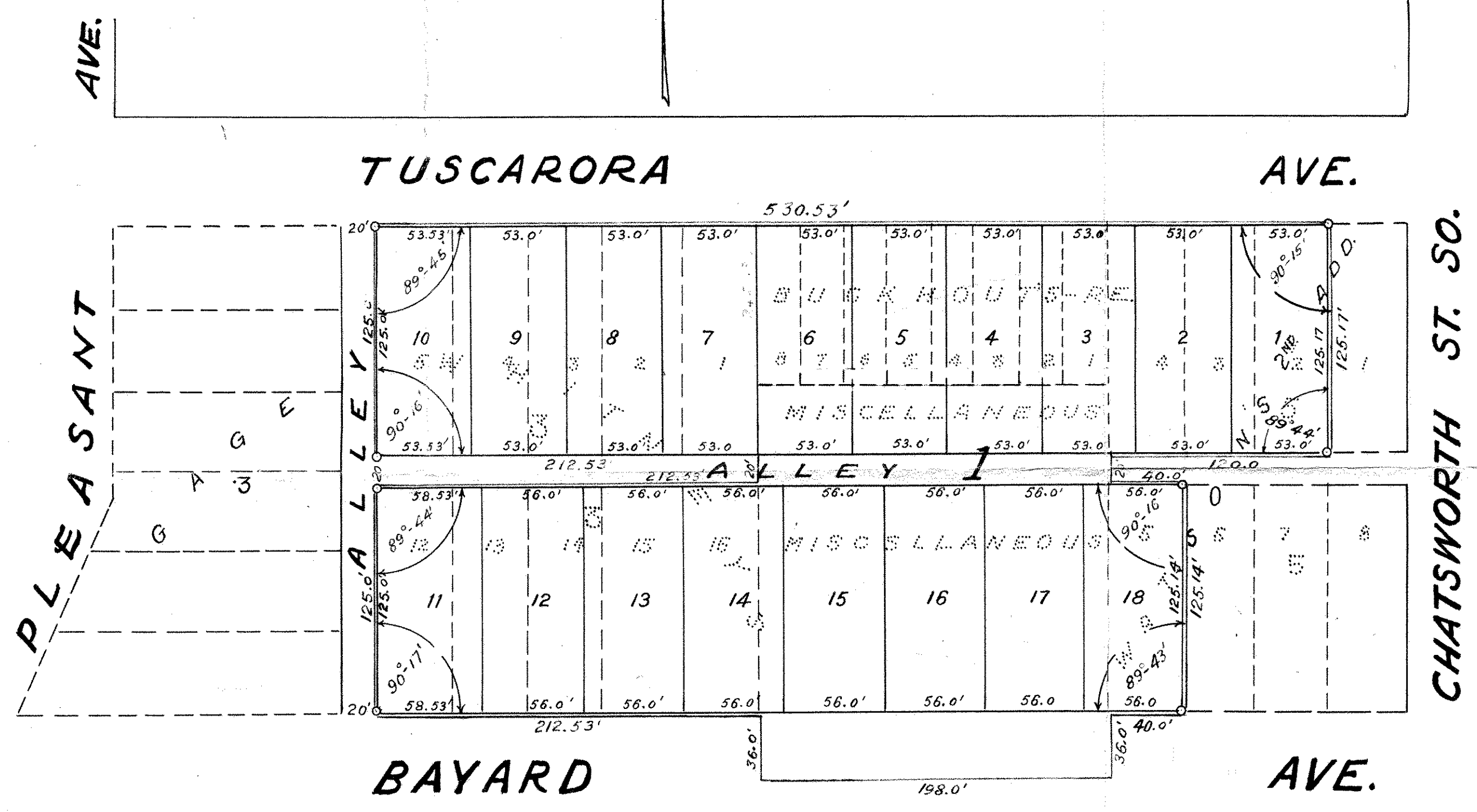
ST. PAUL, MINNESOTA
