That part of the Southwest quarter of the Southwest quarter of Section 1, Township 29, Range described as follows: Beginning at the Southeast corner of said Southwest quarter of Southwest quarter; thence West (assumed bearing) along the South line of said Southwest quarter of Southwest quarter 650 feet; thence North 0 degrees 51 minutes East parallel to the East line of said Southwest quarter of Southwest quarter 286 feet; thence East parallel to South line of said Southwest quarter to the East line of said Southwest quarter of Southwest quarter; thence South 0 degrees 51 minutes West along said line to the point of beginning. Except therefrom that part thereof platted as Kerr Second Addition and subject to rights of public in 17th. Avenue.

DESCRIPTION: (House)
