ROAD: A strip of land for road purposes on and across the SE $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 18, T 29 N, R 21 W, Washington County, Minn., described as follows; commencing at the Northeast corner of said SE $\frac{1}{4}$ of the SW $\frac{1}{4}$, thence S 0°05'E along the East line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$ 301.07 feet to the point of beginning, thence S 58°42'15"W 510.27 feet to a point of curve, thence Southwesterly along a curve with a deflection angle of 32° to the right and a radius of 388 feet for an arc distance of 216.70 feet to end of curve, thence N 89°17'45"W 672.59 feet to a point on the West line of said SE $\frac{1}{4}$ of the SW $\frac{1}{4}$, thence S 0°03'45"E along the West line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$ 60.00 feet, thence S 89°17'45"E 671.77 feet to a point of curve, thence Northeasterly along a curve with a deflection angle of 32° to the left and a radius of 448 feet for an arc distance of 250.21 feet to end of curve, thence N 58°42'15"E 334.05 feet, thence N 89°55'5"E 119.64 feet to a point on the East line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$, thence N 0°05'W along the East line of said SE $\frac{1}{4}$ of SW $\frac{1}{4}$ 142.62 feet to the point of beginning and there terminating; except the East 47 feet thereof for Granada Ave.
