Whereas, Upon the petition of six (6) legal voters, residing or owning real estate within one (1) mile of the road proposed in said petition to be laid out, copies of said petition being first duly posted up in three (3) of the most public places in said town at least twenty (20) days before any action was had in relation thereto; which said proposed new road is set forth and described in said petition as follows, viz:

Beginning at a point on the Centerville Road about 300 ft. from the center of Section fifteen (15) Township thirty (30) Range twenty-two (22) thence NW to the quarter section line of Section fifteen (15) thence North on quarter section line of Sections fifteen (15) and ten (10) or as near said quarter section line as practicable to the NE corner of NW $\frac{1}{4}$ of Section ten (10) or as near said corner as practicable, thence NW through the SE $\frac{1}{4}$ of SW $\frac{1}{4}$ and Lot 2 of Section three (3) to Otter Lake, thence NW along the shore of Otter Lake and on the West side thereof to the town line between the towns of White Bear and Centerville.

And Whereas, Upon receiving said petition we did within thirty days make out a notice and fix therein a time and place at which we would meet and decide upon said application to-wit:

On the 2nd day of April A.D. 1878 at the house of Joseph Freeman on Section fifteen (15) in said town, causing copies of said notice to be posted in three public places in said town, at least ten (10) *days* previous to said meeting, and having met at such time and place as above named in said notice, and being satisfied that the applicant had at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit, we proceeded personally to examine such highway and heard any and all reasons for or against laying out the same, and being of the opinion that such laying out was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of the petitioners and determined to lay out said road, and caused a survey thereof to be made according to the report and plat herewith accompanying.

Beginning at a point on the Centerville Road about 400 ft. from the center of Section fifteen (15) Township thirty (30) Range twenty two (22) running thence Northerly as per courses and distances indicated on plat through Sections fifteen (15) ten (10) three (3) and four (4) in said Township thirty (30) Range twenty two (22) to its intersection with the county line 33 ft. distant from shore of Otter Lake.

It is Therefore Ordered and Determined that a road be and the same is hereby laid out and established according to the description aforesaid and the report and plat accompanying which is hereby made a part of this order, and it is hereby declared to be a public highway four (4) rods wide, the description above given being the center of said road.

Commencing on the Centerville Road about 300 ft. East from the center of Section fifteen (15) Township thirty (30) Range twenty two (22) thence Northwest to the 1/4 section line of Section fifteen (15) thence on the 1/4 section line of Sections fifteen (15) and ten (10) or as near said line as practicable to the NE corner of the NW 1/4 of Section ten (10), or as near said corner as practicable, thence NW through the SE 1/4 of the SW 1/4 and Lot 2 of Section three (3) to Otter Lake, thence NW along the shore of Otter Lake and on the West side thereof to the Town line between the Towns of White Bear and Centerville.
