PETITION FOR CHANGE OR VACATION OF COUNTY ROAD

For Otter Lake Road in Section ten (10) Township thirty (30) Range twenty two (22) Sept. 19/04, Petition received and referred to Committee on Roads and Bridges.

PETITION FOR CHANGE OF COUNTY ROAD

To the Board of County Commissioners of the County of Ramsey, Minnesota:

The undersigned freeholders of the County of Ramsey residing therein petition your Honorable Board for the change of a highway, and not within the limits of any incorporated City, and described as follows:

Known as "Otter Lake Road"

And your petitioners pray that you will change all that portion of said above described highway which runs as follows:

Beginning at the 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22) and running thence North-easterly through the SE 1/4 of said Section ten (10) to a point on the 1/4 section line between the SE 1/4 and the SW 1/4 of said Section ten (10)

And now connected with other roads as follows:

Town Road on North line of S 1/2 of SE 1/4 of Section ten (10) Township thirty (30) Range twenty two (22) and from road running West from the 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22)

So that the same when changed will run as follows:

Beginning at the 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22) and running thence North on 1/4 section line between the SE 1/4 and SW 1/4 of said Section ten (10) to a point where the old road intersects the said 1/4 section line.

And to be connected with other roads as follows:

Town Road running West from 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22).

The names of the owners of the lands, as far as known, through which the same now passes, are: Anna Erhardt, The Church of St. Marys of the Lake, White Bear, Hamm Realty Co.

And the names of the owners of the lands, as far as known, through which the same may pass when changed, are: Anna Erhardt, Hamm Realty Co., Hester Ann Freeman.

And your petitioners pray that you will proceed to change said road, and cause the same to be opened according to law.
