## PETITION FOR CHANGE OF COUNTY ROAD

To the Board of County Commissioners of the County of Remesy, Minnesota;

The undersigned fresholders of the County of Ramsey residing therein petition your Honorable Board for the change of a highway, and not within the limits of any incorporated City, and described as follows: Known as "Otter Lake Road"

And your petitioners pray that you will change all that portion of said

above described highway which runs as follows:

Beginning at the 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22) and running themes Northwesterly through the SE2 of said Section ten (10) to a point on the 1/4 section line between the SE2 and the SE2 of said Section ten (10)

And now connected with other reeds as follows: Town Road on North line of St of SEt of Section ten (10) Township thirty (30) Range twenty two (22) and from road running West from the 1/4 sections corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22)

So that the same when changed will run as follower Beginning at the 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22) and running thence North on 1/4 section line between the SE2 and SV2 of said Section ten (10) to a point where the old road intersects the said 1/4 section line.

And to we connected with other reads as follower Town Road running West from 1/4 section corner between Sections ten (10) and fifteen (15) Township thirty (30) Range twenty two (22).

The names of the owners of the lands, as far as known, through which the same new passes, are: Anna Erhardt, The Church of St. Margs of the Lake, White Bear, Hamm Realty Co.
