

Whereas, Upon the petition of twenty one (21) legal voters who are fresholders and residents of said town within three (3) miles of the road proposed in said petition to be laid out; which said petition was filed with the Town Clerk previous to the time of poeting copies thereof, and copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty (20) days before any action was had in relation themselv, proof of which posting was duly shown to us by affidavit; which said proposed new road is set forth and described in said petition as follows, vis:

Beginning at the MW corner of Section twenty six (26) Township thirty (30)
Range twenty three (23) thence running Fact on the section line to and intersecting
with the County Road known as Victoria Street Road all in the town of Mounts View.

And Whereas, Upon receiving said petition, we did, within thirty (30) days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit! On the 12th day of May A.D. 1962 at the residence of Joseph Lange, causing copies of such notice to be posted in there public places in said Town, at least ten days previous to such meeting! and having met at such time and place as above named in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which use shown by affidavit, we proceeded to examine personally such highway, and heard any and all reasons for or against the laying out the same, and being of epinion that such laying out was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so is as fellows, to-wit!

Beginning at the Northwest Corner of Section twenty six (26) Township thirty (30) Range twenty three (23) Thence running East on the section line to and intersecting with the County Road known as Victoria Street Road, St. Paul, all in the Town of Mounds View.

It is Therefore Ordered and Determined, That a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is declared to be a public highway four (4) reds wide, the said description above given being the center of said road.

## Award of Domages

Whereas, A road was laid out on the 27th day of May, A.D. 1902, by us, the Supervisors of the said Town of Mounds View on the petition of legal veters whe are fresholders and residents of said town within three (3) miles of said road, which said road is set forth and described in the foregoing Supervisors' Order, made by us, and,

Whereas, A part of the damages sustained by reason of the laying out said road has been ascertained by the agreement of the owners of the lands through which said road passes, with us, and a part of the owners of the said lands have in writing released all claims to damages; but not being able to agree with the owners of the following described lands, claiming damages by reason of said highway passing through, and the owners of some of the said lands being unknown, we have assessed the damages to each of such individual claimants with whom we could not agree, and awarded damages to the owners of such lands through which such highway passes as are unknown, at what we deemed just and right; taking into account and estimating the advantages and benefits the road will confer on the claimants and owners, as well as the disabrantages. We have assessed and awarded damages as follows:
