PETITION FOR CHANGE OF COUNTY ROAD

To the Board of County Commissioners of the County of Ramsey, Minnesota

The undersigned freeholders of the County of Ramsey hereby petition your Honorable Board for the change of a highway running into more than one town of said County, and not within the limits of any incorporated City, and described as follows:

Commencing at a point in Mounds View Township between Sections 24 & 25, thence East to the South East corner of the South West quarter of the South East quarter of Section nineteen (19) in White Bear Township; thence South and along the Easterly shore of Vadnais Lake to the South line of lot six (6) in section thirty (30); thence East on the South line of said lot six (6) and through the center of the South West quarter of Section twenty-nine (29) and around the South Westerly shore of Lamberts' Lake to the Centerville Road.

And your petitioners pray that you will change all the portion of said described highway which runs as follows:

From the S. E. corner of the S. W. $\frac{1}{4}$ of the S. E. $\frac{1}{4}$ of Section nineteen (19) in said White Bear Township; thence South and along the Easterly side of Vadnais Lake to the South line of lot six (6); thence East along the South line of said lot six (6) to the S. E. corner of said lot where said road intersects the Town Road running North and South.

So that the same when changed will run as follows: Commencing at said S. E. corner of S. W. $\frac{1}{4}$ of S. E. $\frac{1}{4}$ of said section nineteen (19) in White Bear Township; thence East to the said Town road at the South East corner of said Section nineteen (19); thence South along said Town Road to the South East corner of said lot six (6) in Section thirty (30). 75 Mi

Commencing at a point in Mounds View Township between Section 24 & 25; thence East to the S. E. Corner of the S. W. $\frac{1}{4}$ of S. E. $\frac{1}{4}$ of Section 19 in White Bear Township; thence South along the East Shore of Vadnaia Lake to the South line of lot six (6) in Section 30; thence East on the South Line of said lot six (6) and through the center of the S. W. $\frac{1}{4}$ of Section 29 and around the South Westerly shore of Lamberts Lake.
