WHEREAS, upon the petition in writing of thirty-eight legal voters residing within the limits of the Townships of Rose and Mounds View in the County of Ramsey as the route hereinafter described for a public highway through the said towns, a copy of their petition having been first duly posted as required by law, we, the Committee on Roads and Bridges of the said County of Ramsey, did on the 10th day of April A.D. 1872 personally examine the route proposed in said petition for a county road to-wit:

Commencing at the Southeast corner of Section 3, Township 29 North of Range 23, running thence due North or as near as practicable upon the Section Line to the Northeast corner of Northeast quarter of Section 22, Township 30 North of Range 23.

And having, before determining to lay out said County Road fixed upon a time and place when and where we would meet to hear any reasons for or against laying out the same, notices thereof having been posted up in three public places near the line of said road 30 days previous to the time of such meeting and having met at the time appointed for hearing such reasons and none having been offered against the laying out of said County Road and being of opinion that such laying out is necessary and proper and that the public interest would be promoted thereby, and having granted the prayer of said petitioners and determined to lay out said road we did on the 7th day of May A.D. 1872 cause a survey thereof to be made by a competent surveyor who made a report to us as follows:

Surveyor's Report.

To the Commissioners of Ramsey County, State of Minnesota:

The undersigned, having been employed by you to make a survey of a County Road beginning at the Southeast corner of Section 3, Township 29, Range 23 running due North as near as practicable on the Section line to the Northeast Corner of ^S Northeast quarter of Section 22, Township 30, North of Range 23, would report that the following is a correct survey thereof as made by me under your directions, to-wit:

ASSESSMENT OF DAMAGES

We, the undersigned Committee on Roads and Bridges, Commissioners of Ramsey County, having on the day of May A.D. 1872, upon due application made to us for that purpose, laid out a County Road as follows, to-wit:

Beginning at the Southeast corner of Section 3, Rose Township, near Bennetts Lake, thence due North or as near as practicable on Section line through the Towns of Rose and Mounds View to the Northeast corner of the Northeast $\frac{1}{4}$ of Section 22 in the Town of Mounds View within the limits of said County and certain owners of lands over which said County Road passes, to-wit:

Sarah Brown, T. Jackson, Thomas Stinson, A. Springer, L.P. McLeland, J. G. Killin, J. Godeck, M. Brisaske, C. G. Stout, H. B. Stewart, J. Reeling, P. Patterson, P. Pusey, N. McLane, J. F. Arnstd, Nancy Spencer, T. G. Fletcher, Elenor Miller, William Spooner, C. M. Boyle, Ramsey County, J. J. Dewey, A. Posik, J. L. Kiba, M. Fabyansky, B. Kowaskie, Thomas Ryan, P. Graham, M. L. Marsden, and all others unknown to us in the said Towns of Rose and Mounds View, not having released all claims to damages sustained by reason of laying out and opening said County Road and not having agreed upon the amount of such damages though we applied to them and each of them and their agents or representatives for that purpose and endeavored to make such agreement

We proceeded to assess the same at what we deemed just and right to each individual claimant with whom we could not agree taking into account and estimating the advantages and benefits the road will confer on the claimants for the same as well as all disadvantages.

Therefore we have estimated the advantages of said County Road equal to any and all the damages of the above named owners of lands severally along the line of said County Road as above described in said County.
