STATE OF MINNESOTA) COUNTY OF RAMSEY) SS TOWN OF WHITE BEAR)

Whereas, upon the petition of eight (8) legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within three (3) miles of the road proposed in said petition to be laid out; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said proposed road is set forth and described in said petition as follows, vis:

To extend the Town Road running East and West through the center of SEt of Section ten (10) Township thirty (30) Range twenty two (22) from Otter

Lake Road West to the West line of said SEZ.

And Whereas, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition, to-wit: On the 22nd day of August A.D. 1908, at the intersection of Stillwater St. and Otter Lake Road in Section ten (10) Township thirty (30) Range twenty two (22) causing copies of such notice to be posted in three public places in said . Town, at least ten days before such meeting; and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally upon each of said occupants, preof of which was shown by affidavit, we proceeded to examine personally such highway, and heard all persons interested, and any and all reasons for or against the laying out the same, and being of epinion that such laying out was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so is as follows, to-wit:

No names of owners of lands or description of lands or award of damages

are given.

It is Therefore Ordered and Determined, That a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared to be a public highway four (4) rode wide the said description above given being the center of said road.

Whereas, A read was laid out on the 22nd day of August A.D. 1905, by us, the Supervisors of said Town of White Bear on the petition of eight (5) legal voters who own real estate or who occupy real estate under the Homestead or Pre-emption laws of the United States, or under contract from the State of Missessis, within three (3) miles of said read, which said read is not forth and described in the foregoing Supervisors Order, made by us, and;

Thereas, A part of the damages sustained by reason of the laying sat said road has been ascertained by the agreement of the owners of the lands through which said road passes, with us, and a part of the ewners of the said lands have in writing released all claims to damages; but not being able to agree with the ewners of the following described lands, claiming damages by reason of said road passing through, and the owners of some of the said lands being unknown, we have assessed the damages to each of such individual claimants with whom we could not agree, and awarded damages to the owners of such lands through which such read passes as are unknown, at what we deemed just and right; taking into secound said estimating the benefits the road will confer on the claimants and owners, as well as the disadvantages. We have assessed and awarded damages as follows:

And in case of the following lands and claimants for damages, we estimate that the advantages and benefits said road will confer on them are equal to all damages exetained by them by reason of laying out said road, to-witt
