To the Board of County Commissioners of the County of Ramsey, Minnesota;

The undersigned freeholders of the County of Ramsey residing therein petition your Honorable Board for the change of a highway, not within the limits of any incorporated city, and described as follows:

Beginning on the shore of Bald Eagle Lake in the Center of Lake Ave. Town of Bald Eagle where said Lake Ave. intersects West Ave., thence along the southerly and westerly shore of said lake to the East line of section 3, township 30, range 22, thence north on said section line to the north line of said County.

And your petitioners pray that you will change all that portion of said above described highway which runs through part of lot 1, section 12, township 30, range 22, and lots 6 and 7, section 3, township 30, range 22, so that the same, when changed, will run as follows:

Beginning at a point on the south line of section 3, township 30, range 22, 100 feet west of Number Corner No. 12, thence angle to the right 45 degrees 54 minutes, 165.50 feet to a point, thence angle to the right 10 degrees 46 minutes, 440 feet to a point, thence angle to the right 47 degrees, 170 feet to the south line of the present traveled road in lot 6, section 3, township 30, range 22.
