Whereas, Upon the petition of six (6) legal voters owning real estate or occupying real estate under the Homestead or Pre-emption laws of the United States or under contract from the State of Minnesota within one (1) mile of the road proposed in said petition to be laid out, copies of said Petition having been first duly posted up in three of the most public places in said town at least twenty (20) days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit, which said proposed new road is set forth and described in said petition as follows: vist

Beginning at the 1/4 corners on the East side of Section twelve (12)

Township twenty nine (29) Range twenty three (23) West and running themse

West on the 1/4 line to the 1/4 corners on the West side of said Section twelve
(12) themse West on the 1/4 line through Section eleven (11) to the 1/4 corners
at the SW corner of the SR2 of the WR2 of Section eleven (11) Township twentynine (29) Range twenty three (23) and whereas:

Upon receiving said petition we did within thirty (30) days thereafter make out a notice and fix therein a time and place at which we would meet and decide

upon such application to-wit:

On the 26th day of March 1886 at 2:00 o'clock P.M. at John Burket's house, causing copies of such notice to be posted up in three of the public places of said town at least ten (10) days previous to such meeting and having met at such time and place as above named in said notice and being satisfied the applicant had at least ten (10 days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land thread which such highway might pass by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown us by affidavits, we proceeded to examine personally such highway and being of the opinion that such laying out was necessary and proper and that the public interest would be promoted thereby we granted the prayer of said petitioners and determined to lay out said road the description of which are so laid out is as fellows:

Beginning at the quarter corners on the East side of Section twelve (12)

Township twenty nine (29) Range twenty three (23) West running thence West on the 1/4 line to the 1/4 corners on the West side of Section twelve (12) thence twenty on the 1/4 line through Sec. 41/4 of NEt of Section eleven (11) Tewnship twenty nine (29) Range twenty three (23).

It is Therefore Ordered and Determined that a road be and the same is hereby laid out and established according to the description last aforesaid and it is hereby declared to be a public highway four (4) rods wide the said description above given being the center of said road. 
