Mounds View Township

Petition of Citizens of Mounds View Township asking for the location of a highway running into more than one town.

Commencing at the southeast corner of section 3, township 29, range 23, thence north on section line as near as practicable to the northeast corner of section 27, township 30, range 23, thence west on the section line as near as practicable to the southwest corner of section 22, thence north on the section line as near as practicable to the northeast corner of section 21, thence west to the quarter post between sections 16 and 21, thence north through the center of section 16 and 9 to section 4, thence east as near as practicable on the section line between sections 4 and 9, 3 and 10 to the center of section 3, thence to the quarter post between sections 2 and 3, thence to the Columbus Road in said township 30, range 23.

REPORT OF COMMITTEE ON COUNTY ROAD

Committee appointed June 23, 1877, to examine proposed route by order of Board of County Commissioners proceeded to examine the highway proposed to be located viz:

Commencing at the southeast corner of section 3, in Ross Town, from thence due north on section line as near as practicable, to the northeast corner of section 27 in the town of Mounds View, from thence west to the southwest corner of section 22, thence north as near as practicable to the northeast corner of section 21, from thence west to the quarter post between sections 16 and 21, from thence north through the center of sections 16 and 9 and through sections 4 and 9, 3 and 10 to the center of section 3, from thence to the quarter post between sections 2 and 3, and from thence to the Columbus Road in said township 30, range 23, (Mounds View Township) Ross Town.
