Whereas, upon petition of six legal voters owning real estate or occupying real estate under the homestead or pre-emption laws of the United States or under contrast from the State of Minnesota within one mile of the read proposed in said petition to be laid out, copies of said petition having been first duly posted in three of the most public places in said town, at least 20 days before any action was had in relation thereto, proof of poeting was duly shown to us by affidavit, in which said preposed new road is set forth and described in said petition as fellows:

Beginning at the 1 corners at the center of Section 11, then running due East on the 1 line to the 1 corners of the Southwest corner of SM of the ME1 of Section 11, being a continuation of the read running from said 1 corners East on the 1 line to Mest side of said town.

thereafter make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: on the 9th day of July, 1892, and causing copies of said notice to be posted in three pull ic places in said town at least 10 days previous to said meeting and having met at such time as above named in said notice and being satisfied that the applicants had at least 10 days previous to said time caused said notice of time of hearing to be given to all the occupants of the land through which such highway might pass by serving the same personally or by copy left at the usual place of abode of each of said occupants proof of which was shown by affidavit, we did proceed to examine personally such highway and hear any and all reasons for and against laying out the same and being of the opinion that such laying out was necessary and proper and that the public interest would be premoted thereby, we granted the prayer of said petitioners and determined to lay out said road, the description of which as so laid out is as follows: Beginning at the 1 corners at the center of Section 11, then running due last on the 1 line to the 1 corners at the SW corner of SET of the SET of Section 11, being a continuation of the road running from said 1 corners last on the 1 line to East side of said town.

It is therefore ordered and determined that a road be and the name is hereby laid out and established according to the description last afterested and it is hereby declared to be a public highway 4 rods wide the description above given being the center of said road.

Whereas, Upon the petition of six (6) legal voters owning real estate within one mile of the road proposed in said petition to be laid out, sepies of the said petition having been posted according to law in three (3) of the most public places in the town, before any action was taken therein, preof of which posting was shown to us by affidavit, which said proposed road is set forth and described in said petition as follows:

Beginning at the 1/4 corners at the center of Section eleven (11) them running due East on the 1/4 line to the 1/4 1/4 corners at the SW corner of SE of the NE of Section eleven (11); being a continuation of the read running from said 1/4 1/4 corners East on 1/4 line to East side of said tewn. Having fixed July 9th at 2:00 o'clock P.M. as the time and the read to be laid out the place for meeting to hear all reasons for and against laying out said new read, we caused notices to be posted in three of the mest public places in said town, according to law; stating time and place of meeting.
