RESOLUTION

Aug. 18, 1890

By Commissioner Wright:

Resolved by the Board of County Commissioners of Ramsey County that certain highway or road beginning at the intersection of the easterly boundary line of the City of St. Paul in the County of Ramsey with the section line dividing sections 25 and 36, Town 29, Range 22, thence running easterly along said section line to the easterly boundary line of said Ramsey County so as to be a continuation of Minnehaha St. in said City of St. Paul and the said road is adopted and declared to be a County Road to all and purposes as if the same had been originally petitioned for and laid out as a County Road.

Board of C.C.  
Aug. 29, 1890

Resolved that the 29th day of August at 11 A.M. be the time for a hearing on a petition for a county road known as Minnehaha extension in New Canada Town, signed by Robert Kiefer and others; received April 21st, 1890. The Commissioners to meet at the entrance of the Swedish Cemetery on the line of said road. Resolution adopted.
