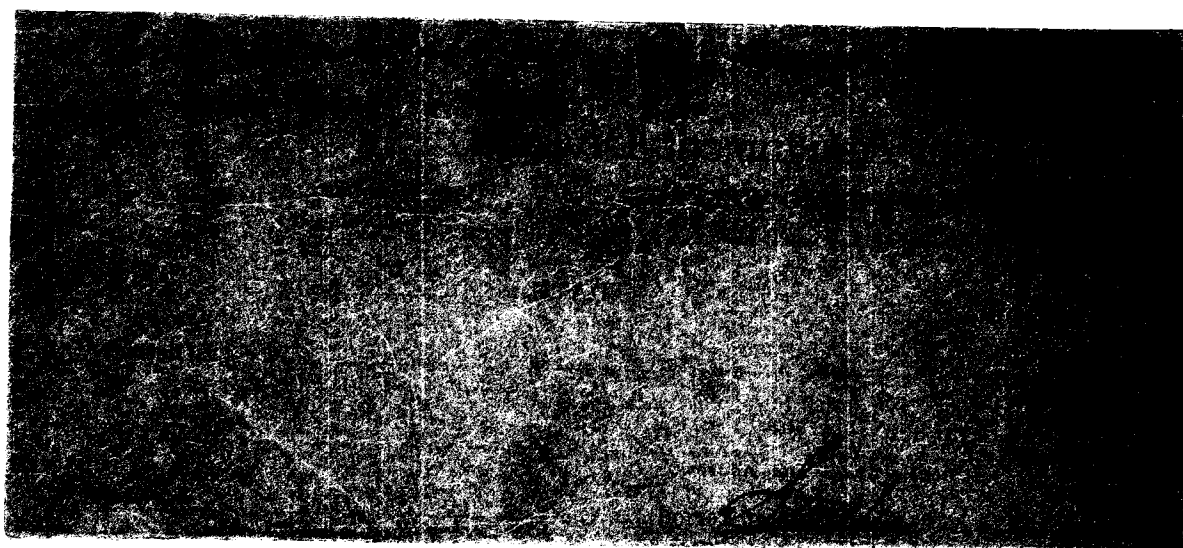

PETITION FOR COUNTY ROAD

66 ft. wide

To The County Board of the County of Ramsey, Minnesota:

The undersigned freeholders of the County of Ramsey hereby petition your Honorable Board for the establishment of a highway, running in said County, and not within the limits of any incorporated city, and described as follows:

Beginning at the southwest corner (SW Cor) of Sec. 12, T. 26, R. 23 and running thence Easterly along the South line of Sec. 12 and the North line of Sec. 13, a distance of approximately one mile to the Southeast Corner (S.E. Cor) of said Sec. Twelve (12) and to be connected with other roads as follows:

1. The East County Line Road on East.
2. East Avenue on West.

and terminating at the East County Line Road.

TO THE BOARD OF COUNTY COMMISSIONERS

The undersigned Committee appointed by you to examine the proposed establishment of a highway, as stated in the petition referred to in your order of appointment made on the 16th day of August, 1926, would respectfully report that we met at the time and place designated in your said order, and proceeded to examine the highway proposed to be established, viz:

Beginning at the Southwest Corner (SW Cor) of Section 12, Township 28, Range 23, running thence Easterly along the South Line of Section 12, and the North Line of Section 13 a distance of approximately one mile to the southeast corner (SE Cor) of said Section 12, and to be connected with other roads as follows:

1. The East County Line Road on East,
2. East Avenue on West,

and terminating at the East County Line Road. Said highway to be four rods in width.

And do hereby by the opinion of a majority of said Committee recommend that the prayer of the said petitioners be granted.
