

Supervisors' Road Order

STATE OF MINNESOTA, County of Rampey, Town of New Canada, SS:

WHEREAS, upon the petition of eight (5) legal veters, who our real estate, or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within one mile of the read proposed in said petition to be laid out, copies of said petition having been first duly posted up in three of the most public places of said Town, atlegst twenty-days before any action was had in relation therete, proof of which posting was duly shown to us by affidavit; which said proposed read is set forth and described in said petition as fellows, vis:

Beginning on the East line of the City limits of the City of St. Paul where the dividing line between section twelve, 12, and thirteen, 13, intersect said city limits running themse East along the dividing line as near as may be between said section twelve, 12, and thirteen, 13, to the East boundary line of Ramsey County and terminating at that point.

thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: on the loth day of Nevember, A.D. 1909 at 10 o'clock in forenoon at Marion store at Highwood, emusing copies of such notice to be posted in three public places in said Town at least ten days previous to such meeting; and having met at such time and place as above maned in said netice, and being satisfied that the applicant had, at least ten days previous to said time, comsed said notice of time and place of hearing to be given to all the eccupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such highway, and heard any and all reasons for or against laying out the same, and being of the opinion that such highway was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners, and determined to lay out said road and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so laid out is as follows, to-wit:

Beginning on the East line of the City limits of the City of St. Paul where the dividing line between section twelve, 12, and thirteen, 13, intersect said city limits running thence East along the dividing line as near as may be between said section twelve, 12, and thirteen, 13, to the East boundary line of Ramony County and terminating at that point.

The board of supervisors of said Town of New Canada held a meeting on the sixteenth and postpened the same until the 23rd of Newsmber, 1909.

IT IS THEREFORE ORDERED AND DETERMINED, that a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway four rods wide, the maid description above given being the center of said road.

Award of Damages

STATE OF MINNESOTA, County of Ramsey, Town of New Canada, 55:

WHEREAS, a road was laid out on the 23rd day of November, A.D. 1909 by us, the Supervisors of the said Town of New Canada on the petition of S legal voters who own real estate or who occupy real estate under the Homestood or pre-emption laws of the United States, or under centract from the State of Minnesota, within one mile of said road; which said road is set forth and described in the foregoing Supervisors! Order, made by us, and

WHEREAS, a part of the damages sustained by reason of the laying out said road has been ascertained by the agreement of the owners of the lands through which said road passes, with us, and a part of the owners of the said lands have in writing released all claims to damages; but not being able to agree with the owners of the following described lands, claiming damages by reason of said highway passing through, and the owners of some of the said lands being unknown, we have assessed the damages to each of such individual claimants with whom we could not agree, and awarded damages to the owners of such lands through which such highway passes as are unknown, at what we deemed just and right; taking into account and estimating the gdvantages and benefits the road will comfer on the claimants and owners, as well as the disadvantages. We have assessed and awarded damages as follows:
