COUNTY COMMISSIONERS ROAD ORDER

STATE OF MINNESOTA) SS COUNTY OF RAMSEY)

At a meeting of the Board of County Commissioners of said County, held May 2nd 1876, the report of the committee appointed by us at our last session to examine the road hereinafter named, reported that they met at the time and place designated in our order of appointment, and examined the highway propesed to be located viz:

Commencing at the Como Road and Minneapolis County Road in Rosetown on the section line between Sections sixteen (16) and seventeen (17) from thence North on section line between Sections 16 and 17. 8 and 9. 5 and 4 to the 1/4 line between NET and SET of Section five (5) thence West on said line 1/2 mile thence North on the line of NET to township line of the towns of Rose and Mounds View in the County of Ramsey and recommended that the prayer of the petitioners for said highway be granted; (it is therefore ordered and determined that the prayer of said petition be granted, and that a highway be and is hereby located according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such road is located that they cause so much of said highway as lies in their respective towns to be opened without delay.
