

COUNTY ROAD "H" or M-2

A ROAD LAID OUT

November 11, 1878

Whereas a road was lain out on the 1st day of November A. D. 1878 by H. C. Marsden, Frank Rosenthal, and Peter Ganser, Supervisors of the Town of Mounds View in the County of Ramsey and State of Minnesota on the application of the requisite number of legal voters residing within one mile of said road as follows commencing at the S. E. corner of Section (9) nine and running due west one half  $\frac{1}{2}$  mile between sections (9) nine and (16) sixteen and terminating at the County road known as the Lake Josephine Road which road passes through the Land of John Goracki, being known and described as follows N. W.  $\frac{1}{4}$  of N. E.  $\frac{1}{4}$  of Section (16) sixteen.

Now therefore it is hereby agreed between the said John Goracki, and the said Supervisors that the Damages sustained by the said John Goracki, by reason of the laying out and opening said road through his said land hereinbefore described be ascertained and fixed, and the same are hereby ascertained and fixed at the sum of ten dollars \$10.00.

In witness whereof the said supervisors and the said John Goracki have hereunto subscribed their names this eleventh 11th day of November A. D. 1878.

PETITION FOR A NEW ROAD

June 24, 1878

To the Supervisors of the Town of Mounds View in the County of Ramsey and State of Minnesota.

The undersigned legal voters residing within one (1) mile of the road to be laid out hereby petition you to lay out a new road as follows; starting at the S. E. corner of Section nine (9) and running due west one half mile between Section (9) nine and (16) sixteen and terminating at the County road known as the Lake Josephine road the description of the lands over which the said new road passes and the names of the owners thereof which are known are as follows, Joseph Przylski the N. E.  $\frac{1}{4}$  of the N. E.  $\frac{1}{4}$  Section (16) sixteen. John Goraski the N. W.  $\frac{1}{4}$  of the N. E.  $\frac{1}{4}$  of Section (16) sixteen.

S $\frac{1}{2}$  of the S. E.  $\frac{1}{4}$  of Section (9) nine all being in the Town of Mounds View, Ramsey County, Minnesota, and your petitioners pray that you will proceed to lay out said road and cause the same to be opened according to law. Said road to be (4) four ~~rods~~ *rods* wide. Dated at Mounds View this 24th day of June 1878.

November 11, 1878

At meeting of the Town Board of Supervisors held this day at the Town Clerks office for the purpose of locating a town road commencing at the S. E. south east corner of Section nine (9) and running due west one half amile between Sections (9) nine and (16) sixteen and terminating at the County Road known as the Lake Josephine Road in Town (30) ~~thirty~~ Range twenty three (23) the names of the owners of lands through which the road passes as known to the petitioners are as follows to wit, John Goracki, Joseph Crylylski, the proceedings of the board all of which was filed in the Town Clerks office on the eleventh 11th day of November 1878.
