AWARD OF DAMAGES

STATE OF MINNESOTA? County of Ramsey, Town of Mounds View, SS:

Whereas, a road was laid out on the within petition on the twenty-six (26th) day of March, A.D. 1887, by us, the Supervisors of the said Town of Mounds View on the petition of eight legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within two (2) miles of said road as under the new Law of said road; which said road being described is set forth and described in the foregoing Supervisors! Order, made by us, and----

Whereas, a part of the damages sustained by reason of the laying out of the said road has been ascertained by the agreement of the owners of the lands through which said road passes, with us, and a part of the owners of the said lands have in writing released all claims to damages; but not being able to agree with the owners of the following described lands, claiming damages by reason of said highway passing through, and the owners of some of the said lands being unknown, we have assessed the damages to each of such individual claimants with whom we could not agree, and awarded damages to the owners of such lands through which such highway passes as are unknown, at what we deemed just and right; taking into account and estimating the advantages and benefits the road will confer on the claimants and owners, as well as the disadvantages. We have assessed and awarded damages as follows:

Thereas, upon the petition of eight (8) legal voters, who can real cetate, or who eccupy real estate under the homostead or pre-emption laws of the United States, or under contract from the State of Minnesota, within two (2) miles of the read proposed in said petition to be laid out under the new read law, espice of said petition having been first duly posted up in three of the nest public places of said Town, at least twenty days before any action was had in relation thereto, proof of which poeting was duly shown to us by affidority which said proposed read is set forth and described in said petition as fellows, vist

Whereas, upon the petition of eight (8) legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within two (2) miles of the road to be laid, or under the new Law of the road proposed in said petition to be laid out copies of said petition having been first duly posted up in three of the most public places of said town, at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed road is set forth and described in said petition as follows, viz:
