Austin legal voters who own real estate or who occupy real estate under the homestead or presention laws of the United States, or under contract from the State of Minusota, within three (3) miles of the read proposed in said petition to be laid out; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said proposed read is set forth and described in said petition as follows, visi Beginning at the intersection of the center line of Lexington Ave. an the Morth line of Section 3, T. 30, R. 23, an extending East on the present read running East and West between Ramsey and Anoka Counties, being about 3/4 of a mile more or less.

The maid road to be 65 ft. wide 33 ft. on either side of the above described center line.

And Whereas, Upon mesiving said petition, we did. within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition. to-wit: on the 18 day of Nov. 1983 at said proposed road, causing capies of such notice to be posted in three public places in said form, at least ten days before such meeting; and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants. proof of which was shown by affidavit, we proceeded to examine personally such roads, and heard all persons interested, and my and all reasons for or against the road the same, and being of epinion that such road was neces sary and proper and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to lay out said read. and caused a survey thereof to bemade according to the report and plat herewith accompanying, the description of which as so follows, to-wit: Beginning Same as above

It is therefore Ordered and Determined. That a road be, and the same is hereby laid out and established according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared to be a public road 66 ft. wide, the said description above given being the center of said road.
