

COUNTY COMMISSIONERS' ROAD ORDER AND

SURVEYORS REPORTS

November 20, 1875.

Co. Rd. "P" or Co. Rd. #6.

Whereas upon the petition in writing of twenty-four legal voters, freeholders residents of the County of Ramsey, for a County Road three copies of their petition having been first duly posted in three public places as required by law and referred to us on the 7th day of June, 1875, we the Committee on Roads and Bridges personally examined the route proposed in said petition for a County Road as follows, to-wit:

Commencing at a point at or near the quarter section post of section 32 and thirty-three in the Town of Mendota View and Sections four and five in the Town of Rose, thence running west along the south line of sections 32 and 33 to the boundary line of Hennepin County.

And before determining to lay out said road, fixed upon a time and place when and where we would meet to hear any reasons for or against laying out the same and having met at the time and place appointed, to-wit: At the Auditor's Office Room no. 1, in the County Courthouse, in the City of St. Paul, County of Ramsey, for hearing such reasons and none having been offered against laying out said road and being of opinion that such laying out is necessary and proper and that the public interests would be promoted thereby and having granted the power of said petitioners and determined to lay out said road. We did on the last day of September, A.D. 1875 cause a survey thereof to be made by a competent surveyor who made report to us as follows:

To the Commissioners of the County of Ramsey and State of Minnesota

The undersigned having been employed by you to make a survey for a road, from the quarter post between sections 5 of the town of Rose and 32 of the town of Mendota View. Thence west on the line between said towns of Rose and Mendota View to the line of Hennepin County, would report that the following is a correct survey thereof, as made by me under your direction, to-wit:

Beginning at the quarter post between sections 5 of Town 29, Range 23 and 32 of Town 30, Range 23. Thence west on town line, 39.80 chains to the corner of sections 5, 6, 31 and 32. Thence west 39.85 chains to quarter post, thence west 39.70 chains, to the corner of sections 1, 6, 31 and 32 and line of Hennepin County, and that herewith is a correct plat of said road, according to said survey.

It is therefore ordered and determined that a County Road, be and the same is hereby laid out and established according to said survey and the first three were assessed and made part of this order which is hereby declared to be a public highway forty rods wide, the line of said survey being the center of said road.

WHEREAS, Upon the Petition in writing of twenty-four (24) legal voters, freeholders, residents of the County of Ramsey for a county road three copies of their petition having been first duly posted in three public places as required by law and referred to us on the 7th day of June 1875, we the Committee on Roads & Bridges personally examined the route proposed in said petition for a county road as follow, to-wit:

Commencing at a point at or near the quarter ($\frac{1}{4}$) section post of sections thirty-two (32) and thirty-three (33) in the Town of Mounds View and sections four (4) and five (5) in the Town of Rose, thence running west along the South Line of Sections thirty-two (32) and thirty-three (33), to the boundary line of Manomin County.

And before determining to lay out said Road, fixed upon a time and place when and where we would meet to hear any reasons for or against laying out the same and having met at the time and place appointed to-wit: At the County Auditor's office, Ramsey County, for hearing such reasons and none having been offered against laying out said Road and being of opinion that such laying out is accepted and proper and that the public interests would be promoted thereby and having granted the prayer of said petitioners and determined to lay out said road. We did on the 20th day of September A.D. 1875 cause a survey thereof to be made by a competent surveyor who made report to us as follows:

It is therefore ordered and determined that a County Road, be and the same is hereby laid out and established according to said survey and the Plat thereunto annexed and made part of this order which is hereby declared to be a Public Highway four (4) rods wide, the line of said survey being the center of said road.
