Whereas, upon the petition of eight (8) legal voters, who can real estate, or who eccupy real estate under the homestead or pre-caption laws of the United States, or under contract from the State of Manageta, within one mile of the read proposed in said petition to be layed out four (4) rods wide, copies of said petition having been first duly posted up in three of the most public places of said foun, at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed----is set forth and described in said petition as follows, vist

Beginning at the section corner between section fifteen (15) and section sixteen (16), twenty-one (21) and twenty-two (22), and running from themse morth to the section corners of nine (9) ten (10) fifteen (15) and sixteen (16) in said town and range.

And Thereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would neet and decide upon such application, to-wit: On the second (2nd) day of September A.D. 1882, at the house of Stephen Zeverski consing copies of such notice to be posted in three public places in each Town at least ten days previous to such meeting; and having not at such time and place as above maned in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the compants of the land through which such highest might pass, by serving the same personally or by copy left at the usual place of abode of each of said compants, proof of which was shown by affidavit, we preceded to examine personally such highest, and heard any and all resons for or against granting out the same, and being of the opinion that such new road was necessary and proper, and that the public interest would be premoted thereby, we granted the prayer of said potitioners, and determined to lay said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so laid out is as follows, to-wit:

Beginning at the section corner between section fifteen (15) sixteen (16) twenty-one (21) and twenty-two (22) and running from theses morth to the section corners of nine (9) and ten (10) fifteen (15) and section cinteen (16) in said town and range.

It is Therefore Ordered and Determined that a road be, and the same is hereby layed out and established according to the description last aferesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway four (4) rede wide, the said description above given being the center of said road.
