## SUPERVISORS ROAD ORDER

February 7th, 1886.

State of Minnesota )

Whereas, upon the petition of eight legal voters, who own real estate, or who compy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within two (2) miles of the read proposed in said petition to be laid out, copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty days before any action was had in relation thereto, proof of which posting was duly shown to us by affidavit; which said proposed road is set forth and described in said petition as follows, vis:

Beginning at the quarter post where the SE, quarter of section four (h) and the SV, quarter of section three (3) meet and running from this point due south on the section line to the intersection of the County read running west to St. Paul and Kettle River road all in said town of Mounds View.

And Whereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place at which we would meet and decide upon such application, to-wit: On the 22nd day of July A.D. 1886, at the House of B.F. Austin causing copies of such notice to be posted in three public places in said Town at least ten days previous to such meeting; and having met at such time and place as above named in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the occupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abeds of each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such highway, and heard any and all reasons for or against laying out the same, and being of the opinion that such highway was necessary and proper, and that the public interest would be premoted thereby, we granted the prayer of said putitioners, and determined to lay out said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so laid out is as follows, to-wit:

Beginning at the quarter post where the SE. quarter of section four (4) and the SW. quarter of section three (3) meet and running from this point due south on the section line to St. Penl and Kettle River read.

It is therefore Ordered and Determined that a road be, and the same is hereby laid out and established to the description last aferesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway four (4) reds wide, the said description above given being the center of said road.
