COUNTY ROAD E or COUNTY ROAD #6-B

Awarding of Damages

IT IS FURTHER ORDERED, That the County Auditor notify the Town Supervisors of each town through which said road is widened of the fact of said widening and that they shall cause to be opened and widened so much of said highway as lies in their respective towns.

AND WHEREAS, At the said hearing, upon said petition and said report of said committee, said Board has determined from said report and the evidence before them, the amount of the damages sustained by said persons and that said proposed widening of said road is of sufficient advantage to said County to warrant the paying of the damages assessed by this Board, the said Board proceeded to assess said damages at what is deemed just and right to each landowner, taking into account the advantages and benefits of said widening of said highway as well as the disadvantages and damages.

IT IS ORDERED, That said damages be and they are hereby assessed to be paid to each person by said County, as follows, to-wit:
