

SUPERVISORS' ROAD ORDER

WHEREAS, Upon the petition of eleven legal voters who own real estate or who occupy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within three (3) miles of the road proposed in said petition to be vacated; which said petition was filed with the Town Clerk, who forthwith presented it to us for action thereon, and which said proposed vacation of the so-called Hanson Road is set forth and described in said petition as follows, viz: Beginning At the Southwest corner of Lot No. 1, Oak Ridge Section number fourteen (14), Town Thirty (30), Range Twenty-three (23), North and West line of said lot number one (1), Section Fourteen (14), Town thirty (30), Range twenty-three (23), North on West line of said Lot No. 1, Town 30, Range 23, Section 14 to the Southwesterly shore of Turtle Lake known as the Hansen Road the original petition on file described below was commencing at said point on said Manomin Road at the center of said section No. 14, thence along the south line of said lot number 2 in said section number 14, eighty (80), rods more or less to the South west corner of said Lot 2, thence North on the West line of said Lot No. 2 to where said line intersects with lower road aforesaid laid out along the southwesterly and westerly shore of Turtle Lake.

AND WHEREAS, Upon receiving said petition, we did, within thirty days thereafter, make out an order or notice of hearing and fix therein a time and place at which we would meet and act upon said petition, to-wit: On the 1st day of November, 1930, at Town Hall, Mounds View, causing copies of such notice to be posted in three public places in said Town, at least ten days before such meeting; and having met at such time and place as above named in said notice, and being satisfied that the petitioners had, at least ten days previous to said time caused said notice of time and place of hearing to be given to all the occupants of the land through which such road might pass, by serving the same personally upon each of said occupants, proof of which was shown by affidavit, we proceeded to examine personally such road, and heard all persons interested, and any and all reasons for or against the vacation of the same, and being of opinion that such vacation was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners and determined to vacate said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so vacated is as follows, to-wit: ~~Beginning~~

That part of the Town Road running North & South on the line between Government Lots 1 and 2 in Section 14, Township 30, Range 23, which lies North of the North line of Margaret St., in Oak Ridge produced Westerly in a straight line across said road.

IT IS THEREFORE ORDERED AND DETERMINED, That a road be, and the same is hereby vacated and ~~established~~ according to the description last aforesaid, and the report and plat herewith accompanying which is hereby made a part of this Order, and it is declared ~~to be a public~~ ~~road~~ that said public road be vacated, the said description above given being the center of said road.

Given under our hands this 15th day of November, 1930.
