Order laying out a New Road beginning near Louis Sansevier

STATE OF MINNESOTA, County of Ramsey, Town of White Bear,

Whereas, upon the petition of six legal voters, residing or owning real-estate, within one mile of the road proposed in said petition to be laid out, Copies of said petition having been first duly posted up in three of the most public places in said town at least twenty days before any action was had in relation thereto; which said proposed new road is set forth and described in said petition as follows, viz:

Beginning at a point on the Labore Road where the ^{sec} section line of sections 28 and 33 intersects said road, thence west along said section line to the Saint Paul and Centerville Road in sections 29 and 32. And whereas upon receiving said petition we did, within thirty-days, make out a notice and fix therein a time and place at which we would meet and decide upon such application to-wit:

On the 25th day of August, A.D. 1875 at the hour of 9 o'clock A.M. at the house of Louis Sansevier on section 28 in said town, causing copies of such notice to be posted in three public places in said town, at least ten days previous to such meeting and having met at such time and place as above named in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused such notice of time and place of hearing to be given to all the occupants of the land through which said highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants group of which was shown by affidavit, we proceeded to examine personally such highway and heard any and all reasons for or against laying out the same, and being the opinion that such laying out was necessary and proper, and that the public interest would be promoted thereby, we granted the prayer of said petitioners, and determined to lay out said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, by a competent surveyor, whose report is as follows:

To the Supervisors of the Town of White Bear, in the County of Ramsey and State of Minnesota: The undersigned having been employed by you to make a survey of a road, beginning at a point on the Labore Road where the Section line of Sec. 28 and 33 intersects said road, thence west along said section line to the Saint Paul and Centerville Road in sections 29 and 32, would report that the following is a correct survey thereof as made under your directions to-wit:

Commencing at a point on the Labore Road where said road crosses the section line between sections 28 and 33, Township 30, Range 22, 1310 ft. east of the $\frac{1}{4}$ post corner on said section line; running thence west along said section line 3957 Ft. to corner of sections 28, 29, 32 & 33. township 30, range 22, thence west along the section line between sections 29 and 32, Township 30, Range 22, 717 ft. to where said section line intersects the Saint Paul and Centerville road, and that the accompanying is a correct plat of said road according to said survey.

It is therefore ordered and determined that a road be, and the same is hereby laid out, and established according to the description aforesaid and the report and plat accompanying which is hereby made a part of this order and it is hereby declared to be a public highway four rods wide the description above given being the center of said road.
