

**PETITION FOR A ROAD**

April 4, 1888.

To the Board of County Commissioners of Ramsey County.

The undersigned freeholders of the County of Ramsey here by petition your honorable board for the changing and location of a portion of Highway running into more than one town of said County and not within the limits of any incorporated city, and described as follows:

Beginning at a point at the quarter post on south section line of Section 13, Thirteen, in Township 30, thirty, Range 23, twenty-three, running from thence due north on said quarter line 80 rods, then due west on half-quarter line 80 rods to the intersection of the County road known as the Rice Street Extension.

The names of the owners of the lands through which said highway may pass as follows:
