Extension of Barlow Road

STATE OF MINNESOTA )  
COUNTY OF RANSEY )SS

At a meeting of the Board of County Commissioners of said County, held January 17th, 1887, a copy of the report of the committee appointed by us at our last session to examine the road hereinafter named, having been duly returned, by which said report it appears that the said committee met at the time and place designated in our order of appointment and examined the highway proposed to be extended, viz: Beginning on or about the half Section line East of the center of Sec. 20, and West of the center of Sec. 21, of the Town of Mounds View; thence running North on the Section line (as near as practicable) between Sec. 20 and 21, 16 & 17, 8 & 9 & 4 & 5 to the Anoka County line. This will be the extension of what is known as the Barlow road; and recommended that the prayer of the petitioners for the extension of said highway be granted; and a majority of the Board of County Commissioners being of the opinion that the public interest would be promoted by the extension of said highway and that the extension of said road would be of sufficient advantage to the County to warrant the paying of the damages hereinafter assessed, we do hereby order and determine that the prayer of said petitioners be granted, and that a highway be and is hereby extended according to the description above given, which is hereby declared to be a public highway, and the Auditor is hereby directed to notify the Supervisors of the several towns through which such highway is extended, that they cause so much of said highway as lies in their respective towns to be opened without delay.

We have assessed the damages sustained by reason of the extension of said road to the lands over which the same passes and to the owners thereof; Being equal to the benefits thereon.

Extension of Barlow Road

TO THE BOARD OF COUNTY COMMISSIONERS, OF RAMSEY COUNTY, MINNESOTA:

The undersigned freeholders of the County of Ramsey hereby petition your Honorable Board for the extension of a highway running into more than one town in said County and not within the limits of any incorporated City, described as follows, to-wit:

Commencing on or about the half section line East of the center of Section 20 and West of the center of Section 21 of the Town of Mounds View; thence running North on the Section line (as near as practicable) between Sections 20 & 21, 16 & 17, 8 & 9 and 4 & 5 to the Anoka County line.
