Whereas, upon the petition of twelve legal voters, who own real estate, or who occupy real estate under the homestead or pre-emption laws of the United States or under contract from the State of Minnesota, within one mile of the read proposed in said petition to be vacated, copies of said petition having been first duly posted up in three of the most public places of said Town, at least twenty days before any action was had in relation therete, proof of which posting was duly shown to us by affidavit, which said proposed read is set forth and described in said petition as follows, vist

Beginning at the Southwest corner of Block 10, Gladstone Ramsey County Minnesota according to the plat thereof on file and on record in the effice of the Register of Beeds in and for said Ramsey County and including that pertian of Gladstone street in said plat of Gladstone described as fellows; East 1/2 of said Gladstone street being a strip thirty feet wide running along the entire length of the west line of Block 10 in said plat of Gladstone north of the right of way of the St. Paul and St. Croix Falls R.R. Co.

And Whereas, upon receiving said petition, we did, within thirty days thereafter, make out a notice and fix therein a time and place of which we would meet and decide upon such application, to-wit: On the 5th day of June A.D. 1894, at----causing copies of such notice to be posted in three public places in said Town at least ten days previous to such meeting; and having met at such time and place as above named in said notice, and being satisfied that the applicant had, at least ten days previous to said time, caused said notice of time and place of hearing to be given to all the eccupants of the land through which such highway might pass, by serving the same personally or by copy left at the usual place of abode of each of said occupants, preef of which was shown by affidavit, we proceeded to examine personally such highway, and heard any and all reasons for or against altering the same, and being of the epinion that such vacating was necessary and proper, and that the public interest would be premoted thereby, we granted the prayer of said petitioners, and determined to vacate said road, and caused a survey thereof to be made according to the report and plat herewith accompanying, the description of which as so laid out is as fellows, to-wit:

Beginning at the Southwest corner of Block 10, Gladetone Ramsey County Minnesota according to the plat thereof on file and on record in the effice of the Register of Beeds in and for said Ramsey County and including that portion of Gladetone street in said plat of Gladetone described as follows: East 1/2 of said Gladetone street being a strip thirty feet wide running along the entire length of the West line of Block 10, in said plat of Gladetone North of the right of way of the St. Paul and St. Croix Falls R.R.Go.

It Is Therefore Ordered and Determined that a road be, and the same is hereby vacated and established according to the description last aforesaid, and the report and plat herewith accompanying, which is hereby made a part of this Order, and it is hereby declared to be a public highway thirty feet wide, the said description above given being the center of said road.
