Whereas, Upon the petition of seven legal voters who own real estate or who compy real estate under the homestead or pre-emption laws of the United States, or under contract from the State of Minnesota, within two (2) miles—of the cartway proposed in said petition to be laid sut; which said petition was filed with the Town Clerk previous to the time of pesting copies thereof, and copies of said petition having been first duly pested up in three of the most public places of said Town, at least twenty days before any action was had in relation thereto, proof of which pesting was duly shown to us by affidavit; which said proposed cartway is set forth and described in said petition as follows, viz:

Beginning at the NE. corner of the SE. quarter of the NV. quarter of Section 24, Township 25, Range 22, thence running South on the North and South quarter section line of said section 24 to the center thereof, being the Southeast corner of the said SE. quarter of the NV. quarter of Section 24, Township 25, Range 22.
