and others for the change of a County Road.

The above entitled matter come on for final hearing before the County Board of Ramsey County, State of Minnesota, on the 15th day of December, 1922, at 10 o'clock A.M., at C.H. & C.H. Bldg. Saint Paul, in said County and State; and the said board having heard all parties interested and duly considered the same, finds as follows:

First: That said County contains more than sixty thousand voters, and that said petition has been duly signed by twenty-five fresholders of said county:

Seconde—That said petition was duly presented to said Board at a session thereof on the 5th day of November, 1922; and on said date last stated said Board, having first determined said petition to be reasonable on its face, did order a final hearing thereon at C.H. & C.H. Bldg. St. Psul, in said County and State on the 18th day of December, 1922 at 10 o'clock A.M., and did appoint from its members a committee consisting of Carr, Churchill, Farrell, Freeman, Keller, Lind and Welson to examine the route of said change of said road proposed in said petition, and tid in said order fix the time and place upon said route at which said opmulttee should meet for said purposes to—wit: at New Brighton road and Snelling Avenue Extension on the 7th day of December, 1922, at 2 o'clock P.M.:

Third:—That said Board did cause notice of said hearing and of the said time and place of said meeting of said committee to be posted in sach town affected by said proposed change of said road, to-wit in the towns of Rose and Mounds View, in said County, setting forth a copy of said petition, at least twenty (20) days before the time fixed for the meeting of said committee and not less than thirty (30) days before said time of said hearing on said petition; and that due proof of the posting of said motice has been made and filed herein:

Fourth:---That said committee did meet at the said time and place designated for their said meeting and did examine said proposed change designated in said petition, and have duly made and filed their report setting forth the courses and distances thereof and recommending the granting of said petition;

Fifth:—That at said hearing said Board did hear all parties interested as to the necessity for, and as to the amount of the Damages to land owners through whose land said proposed change of said road shall pass, assessing each parcel of said land separately; and did thereupon determine that the said change of said road is necessary and of sufficient advantage to warrant the payment of the damages so assessed:

It Is Therefore Hereby Ordered. That said petition be, and the same hereby is granted; and that said change of said read be, and hereby is, established to run according to said report of said committee by courses and distance as follows, to wit:

Beginning at a point in the present road where the same angles morthwesterly from the south line of the north half of WE, quarter of section 4, township 29, range 23; and running thence due west along said south line of morth half of WE, quarter of section 4, and terminating at the SW, corner of said morth half of WE, quarter; and to be four (4) rods in width, and to be connected with other reads as follows: So-called New Erighton road at said SW, corner.

It Is Hereby Further Ordered, That the County Anditor of said County notify the Town Boards of said Towns of Rose and Mounds View in said County of the establishment of said change of said road; and that said Town Board carry out the determinant tions of this order in their respective towns:
