TO THE BOARD OF COUNTY COMMISSIONERS OF RAMSEY COUNTY, MINNESOTA

The undersigned freeholders of the County of Ramsey hereby petition your honorable board for the change of the highways running into more than one town of said County, and not within the limits of any incorporated City, and described as follows: the first highway to be changed is known as the Stillwater and Centerville Road-Beginning at a point on said Stillwater and Centerville road, where said road crosses the Stillwater branch of the "St. Paul and Duluth Railroad" in lot (4) Section (12) Town (30) Range (22), thence North and East along the center of Stillwater Street, so-called in a platted tract of land called "Garden Place" in said Town of White Bear, to the County line between the Counties of Ramsey and Washington. The second highway to be changed is known as the St. Paul and Centerville road. Beginning at the intersection of Portland Avenue and Stillwater Street in said platted tract of land, known as Garden Place, in said Town of White Bear; thence North along the center of said Portland Avenue to the crossing of the creek on said Portland Avenue.

The road proposed to be changed passes through the land of Mr. David Tice, and has been, or will be, dedicated for a public Street.

And your petitioners pray that you will proceed to change said highways, and cause the same to be opened according to law. Dated this 29th day of July-84.
